1. Consignors must be current (2021) members of the Saskatchewan Sheep Breeders Association. If the membership is not current, the membership must be paid for before the animals are entered into the catalogue.
2. All animals must be born into the property of the consignor, and purebreds must be registered with the Canadian Livestock Registry Corporation.
3. Breeders may enter as many ewes as they wish. There must be one ewe being entered for every ram that is being entered.
4. A \$20.00 non-refundable entry fee for each animal/pen entered. The entry fee will be deducted from the 7% commission fee at the time of sale. Payment can be made by cheque to Saskatchewan Sheep Breeders Association or e-transfer sksheepbreeders@gmail.com. Entries can be submitted by e-mail to sksheepbreeders@gmail.com, fax to 1-306-483-2598 or mail - Box 179, Oxbow, Saskatchewan S0C 2B0. A confirmation e-mail will be sent when entries are received. Cheques can be mailed to Box 179, Oxbow, Saskatchewan, S0C 2B0.
5. The closing date for entries is June 15th, 2021. Pictures, Videos, Registration Papers, Genovis Certificate (if applicable), Semen Testing Evaluations (if applicable) closing date is July 1st, 2021.
6. All photos and videos of animals will be subject to a check by the culling committee; their decision is final.
7. Please submit information of the animal along with pictures/videos to sksheepbreeders@gmail.com. The consignors are responsible for the accuracy of the information provided. Official entry forms must be used.
8. All signed registrations papers must be received by the Saskatchewan Sheep Breeders Association by July 1st, 2021, to participate in the sale. Do not delay in sending in the paperwork, as there will be no exceptions to this! Should the animals not sell, the registration paperwork will be returned to the owner. If any GenOvis information has been provided for the catalogue, please include the GenOvis certificate as well.
9. No substitutions will be allowed.
10. Funds will be distributed to the consignor after the sale once funds from the purchaser have been cleared.
11. If there are any transportation options, they will be listed on the websites; however, the seller and purchaser must arrange the transportation and payment for transportation between themselves.
12. Unless otherwise stated, all animals are not export certified. Any costs associated with export certification are the purchaser's responsibility unless prior arrangements have been made between the seller and purchaser.

Photo and Video Links:

1. All photos will need to be received by the SSBA by June 15th, 2021. You can provide a link to your own videos as well, and all media is to be submitted electronically to sksheepbreeders@gmail.com.
2. The seller is responsible for providing current and unaltered photos of the animals. All images should be on solid ground and show all sides of the animal (front, back and both sides) and CSIP tag number or tattoo matching their registration papers.
3. Animals must be completely slick sheared with head and leg details up to the owner's discretion.
4. Wool breeds must supply photos of parted fleece.

If purebred - this sale is intended to improve the purebred industry, and ultimately the best animals are expected to be provided to maintain the integrity of your production. If photos have not been received and approved by the Sale Committee, those animals are unable to participate in the sale.

Time Auction Event:

1. This is a timed auction event; bidding will commence for all animals on July 21st, 2021, at 1:00 p.m. CST and will end at 1:00 p.m. on July 24th, 2021, at 1:00 p.m. CST. This is a "racehorse style" event - please see DLMS racehorse style rules for more information.
2. Within each breed, there will be: Yearling ewes, senior ewe lambs, junior ewe lambs, yearling rams, senior ram lambs, and junior ram lambs.

Definitions for these are:

Yearling ewe - born September 1st, 2019 to August 31st, 2020

Senior ewe lamb - born September 1st, 2020 to December 31st, 2020

Junior ewe lamb - born January 1st, 2021 and younger

Yearling ram - born September 1st, 2019 to August 31st, 2020

Senior ram lamb - born September 1st, 2020 to December 31st, 2020

Junior ram lamb - born January 1st, 2021 and younger

Health and Soundness:

1. All animals will be rigidly culled by the SSBA culling committee based on the photos and videos submitted prior to the sale. The culling committee may ask for additional photos if there is any question about health or soundness. Please inspect your animals carefully. The following list outlines some of the undesirable physical traits that could serve as a cause for an animal to be culled but does not exclude other reasons that an animal may be culled. The culling committee will not take ANY responsibility for any defects below that are not culled for, that do not appear in photos or videos or that are misrepresented by pictures or videos.

- a. Malocclusion/dental alignment;
- b. Lameness;
- c. Presence of external parasites;
- d. Orf lesions;
- e. Abscess;
- f. Entropion;
- g. Genital malformation;
- h. Body condition score less than 2;
- i. Tail length;
- j. Any other condition that concerns the committee.

2. The committee is authorized to settle all disputes regarding culling and to interpret the rules. The committee culls based on health and sale standards, not breed standards. Their decision will be final. All animals that have been culled are not permitted to participate in the sale.

Registration:

1. Original registration certificates **must be signed on the back for transfer** and submitted to the SSBA no later than July 1st, 2021. Any papers received after this date will be unable to participate in the sale. There will be NO EXCEPTIONS. It will be the responsibility of the consignor to ensure that the papers are submitted on time. Please ensure they are sent to Pamela Bartlett, Box 179, Oxbow, Saskatchewan, S0C 2B0. If you prefer to courier them, please use the following address Pamela Bartlett, 307 Main Street, Oxbow, Saskatchewan, S0C 2B0.

2. Failure to supply the registration certificates will cause the animal to be excused from the sale. Following the sale and financial settlement, the SSBA will process the transfers. The transfer cost will be deducted from the consignor's sale proceeds along with the 7% commission fee, with the entry fee being credited towards the commission fee. The transferred registration paper will be sent directly to the buyer from the CLRC.

Identification:

1. All consigned animals must either bear legible tattoos or paired CSIP tags. Confirmation that the identification stated on the registration paper is borne by the consigned animal is the seller's responsibility. All consigned animals must bear a CSIP tag according to CSIF regulations. Animals failing to meet the identification standards will not be permitted to participate in the sale.

2. Any animals stating genotype results in their description will require proof with their registration papers.

Commission:

The sale commission is 7%. Sale commission will be deducted from the consignor's proceeds, along with the applicable transfer fees. If a reserve bid is provided and the animal does not sell, the consignor is still responsible for the commission based on the reserve bid. All animals in the sale will have a minimum \$250.00 bid price.

Buyers:

Buyers must be registered with the auction company and must provide their full name, address, telephone number, and e-mail address, as this will indicate exactly how each animal is to be transferred.

Terms:

Payment is preferred by e-transfer - sksheepbreeders@gmail.com, but bank drafts and personal cheques will also be accepted. All cheques should be made out to Saskatchewan Sheep Breeders Association. Registration papers will not be submitted to CLRC until the bank has cleared all payments. Payments or proof of payments mailed are to be made within 3 (three) days of the sale's ending.

Guarantee:

1. Each consignor guarantees clear rights and title to all animals that present for sale.
2. All males are guaranteed breeders. Should any ram fail to prove to be a breeder, any claim for adjustment must be made within 12 months of the date of sale. A satisfactory settlement shall be deemed to replace another ram of equal value and health status or refund the purchase price.
3. All females are guaranteed breeders. Should any female 12 months of age or older, not pregnant at the time of sale, fail to become pregnant during the current breeding season, the purchaser has the right to claim adjustment in writing to the seller within 12 months of the sale. Should any female younger than Twelve months of age and not pregnant at the time of sale, fail to become pregnant during the current breeding season, the purchaser should notify the seller within 12 months from the date of purchase, but wait to see if the ewe again fails to become pregnant by 24 months of age, before claiming adjustment in writing to the seller. Satisfactory settlement shall be deemed to replace another ewe of equal value and health status or refund of the purchase price.
4. The purchaser shall notify the seller as soon as any concern with an animal arises.
5. Even if marked prior to the sale, exposed ewes of any age are not guaranteed to be pregnant or produce living lambs.
6. Under no conditions will the seller be liable for more than the original purchase price of the animal.
7. The seller may direct the marketing of the animal and refund the difference between the purchase price and the market value as shown on the sales receipt.
8. All transportation charges are the responsibility of the buyer.
9. Any settlement of such guarantee is between the seller and buyer is subject to the restrictions set out above.
- 10. The Saskatchewan Sheep Breeders Association assumes no responsibility, expressed or implied, regarding this guarantee or the restrictions set out above.**

Risk/Removal:

11. All animals are at the purchaser's risk as soon as sold. Arrangements should be made within seven days between the seller and buyer or unless other terms are agreed upon.

Liability:
